The declaration of the Ministry of Labour  
on the extension of due date of contribution filing and payment  
via electronic systems (e-Payment) B.E. 2562 (2019)

Whereas it is expedient to extend the due date of contribution filing and payment via electronic systems (e-Payment) to facilitate the ease of doing business of employer which shall improve Thailand's ranking in the World Bank's Ease of Doing Business and to protect the interest of employees in accessing social security's benefits.

By virtue of Section 84/2 of the Social Security Act B.E. 2533 (1999) amended by the Order of the Head of the National Council for Peace and Order No. 21/2560 on Amendment of Laws to Facilitate the Ease of Doing Business ordered on 4 April B.E. 2560 (2017), the Minister of Labour, with the approval of the Cabinet, hereby issued the following declaration:

1. Extend the due date of contribution filing and payment, for the employer who files and pays the contribution in compliance with section 47 of the Social Security Act B.E. 2533 (1999) amended by the Social Security Act (the fourth edition) B.E. 2558 (2015) via electronic systems (e – Payment), for another 7 working days starting from the day after the fifteenth day of the month following the month of deduction.

The execution of the first paragraph shall be applied to the contribution filing and payment of salaries of twenty-four months starting from the month this Declaration come into force.

2. This Declaration shall come into force from the day following the date of its publication in the Royal Thai Government Gazette.

In order to continue facilitate the ease of doing business of employer and protecting the interest of employee in accessing social security's benefits, the extension of due date of contribution filing and payment via electronic systems (e – Payment) is deemed appropriate.

By virtue of Section 84/2 of the Social Security Act B.E. 2533 (1999) amended by the Order of the Head of the National Council for Peace and Order No. 21/2560 on Amendment of Laws to Facilitate the Ease of Doing Business ordered on 4 April B.E. 2560 (2017), the Minister of Labour, with the approval of the Cabinet, hereby issued the following declaration:

1.
